NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

The work we propose is:

1. Removal of the existing pews, choir stalls and two front seating rails. This will be done by a flooring contractor (ACC Leisure Maintenance Ltd, Horsham), prior to the floor being refurbished. The contractor has offered to dispose of the pews, if we are unable to sell them elsewhere.

The removal of the pews will leave some floor tiles with holes. These tiles will be replaced as part of the project.

2. Purchase and install 150 LAMSH chairs supplied by Alpha Furniture. 120 of these will not have arms, 30 will have arms. The chair back will be wooden (to remain in keeping with the style of the building) and will have a book trough fitted to the back. The seating pad will be covered with a neutral colour 'nappa' finish, to protect from staining and with greatest durability. We have been advised that this finish will best maintain the present acoustics of the space.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
